- Re-use redundant equipment such as computers and screens, or supply them to charities, schools etc., to support the education system as part of our environmental stewardship and social responsibility.
- We refrain from the use of environmentally hazardous chemicals for cleaning purposes in all our offices.
- Ensure purchasing practices require utilise energy-efficient electrical appliances in our office premises wherever possible to reduce the depletion of natural resources.
- Integrating environmental objectives into our client interfaces and communications.
- Ensuring that any subcontractor auditors, inspectors, trainers, and experts that we contract embrace and comply with our environmental policies and conditions.
